

1                   **Resolution Calling for Federal Recognition of the**  
2   **Duwamish Tribe**

3  
4   **WHEREAS** the ancestral lands of the Duwamish Tribe include the current boundaries  
5 of the City of Seattle, and members of the Duwamish Tribe continue to reside on those  
6 lands;

7  
8   **WHEREAS** the Duwamish Tribe, represented by Chief Si'ahl (Seattle), was the first  
9 signatory of the Point Elliott Treaty of 1855, guaranteeing the Tribe rights and federal  
10 recognition, but the government of the United States of America has not honored the  
11 provisions of that treaty with respect to the Duwamish Tribe;

13   **WHEREAS** the Duwamish Tribe received federal recognition by Executive Order of  
14 President Bill Clinton on January 19, 2001;

15  
16   **WHEREAS** that Executive Order was rescinded by the Bush Administration on January  
17 21, 2001;

18  
19   **WHEREAS** four bills to extend federal recognition to the Duwamish Tribe have been  
20 submitted by Representative Jim McDermott (HR 477 - Jan. 29, 2003; HR 852 - Feb. 16,  
21 2005; HR 949 - Feb. 8, 2007; HR 2678 - June 3, 2009), which Congress has failed to act  
22 upon; and

24   **WHEREAS** the State Democratic platform calls for “[r]estoration of federal recognition  
25 for formerly recognized Tribes”; the King County Democratic Platform states  
26 specifically that “[f]ederal recognition of the Duwamish tribe must be restored”; and the  
27 46th District platform declares support for “[r]einstating federal recognition of the  
28 Duwamish tribe”;

30   **THEREFORE BE IT RESOLVED** that we affirm our support for federal recognition of  
31 the Duwamish Tribe as provided by President Clinton’s Executive Order; and

33   **THEREFORE BE IT FURTHER RESOLVED** that we urge all members of Washington  
34 State’s Congressional delegation to sponsor and support legislation to accomplish such  
35 recognition, and to notify us of their actions toward rectification of this unfortunate  
36 miscarriage of justice.
