

1                                   **Resolution in Support of keeping open**  
2 **Washington State’s network of Residential Habilitation Centers**  
3 **and reversing the Department of Social and Health Services’**  
4 **policy of restricting admissions to the centers**  
5

6 **WHEREAS**, it is the Constitutional obligation of the State of Washington to “foster and  
7 support” its Residential Habilitation Centers (RHCs) for people with developmental  
8 disabilities; and  
9

10 **WHEREAS**, Washington State law “permanently established” the State’s five RHCs,  
11 including Fircrest School in Shoreline, Frances Haddon Morgan Center in Bremerton,  
12 Rainier School in Buckley, Yakima Valley School in Selah and Lakeland Village in  
13 Medical Lake, to “provide services to persons with developmental disabilities,”; and  
14

15 **WHEREAS**, Washington State’s network of RHCs are an essential component of the full  
16 continuum of care provided for its citizens with the highest needs; and  
17

18 **WHEREAS**, the five RHCs meet and exceed the very highest requirements of patient  
19 care and have set the bar to which other care facilities aspire; and  
20

21 **WHEREAS**, by Federal law, families and guardians have the right to choose RHC care;  
22 and  
23

24 **WHEREAS**, the number of residents at RHCs has declined because of the Department  
25 of Social and Health Services’ de facto moratorium on admissions and not because the  
26 need for their services has diminished; and  
27

28 **WHEREAS**, the Department of Social and Health Services, circumventing the  
29 Washington State Constitution and the State Legislature, has made it clear that it  
30 intends to close Fircrest School, and ultimately all of the RHCs in Washington State, and  
31

32 **WHEREAS** numerous studies have shown that significant savings are clearly not  
33 possible by forcing individuals to move from RHCs into community placements; and  
34

35 **WHEREAS**, numerous studies have shown that forcing RHC residents to move would  
36 cause real harm to real people by greatly increasing their likelihood of dying;  
37

38 **THEREFORE BE IT RESOLVED**, that Fircrest School in Shoreline and all of the RHCs  
39 must remain open and remain a viable choice by families and individuals, and  
40 Washington State’s network of RHCs be funded to provide professional services to  
41 people with developmental disabilities who live in the surrounding communities, and  
42

43 **BE IT FURTHER RESOLVED**, that the Washington State Democratic Party go on  
44 record as opposing the closure of any of Washington State's RHCs and that admissions  
45 to the centers be reopened to those families and guardians who choose these services.

57 "Pass" at its September 10, 2006 meeting in Ellensburg. The resolution will be  
58 forwarded to the WSDCC at its next meeting on September 29 - 30, 2006 in Tacoma.

60 The WSDCC passed this resolution at its September 30, 2006 meeting in Tacoma.
