

## Boycott Burger King! Justice for Farm Workers!

3 **WHEREAS**, farm workers who pick tomatoes for the fast food industry are among this  
4 country's most exploited workers; and

5  
6 **WHEREAS**, they suffer from sub-poverty wages; have no right to form unions, and  
7 have no benefits of any kind; and

8  
9 **WHEREAS**, the Coalition of Immokalee Workers (CIW) which represents Florida farm  
10 workers has been fighting for many years to increase the price that farm workers are  
11 paid per pound for the tomatoes they pick; and

12  
13 **WHEREAS**, most pickers are paid virtually the same that they were paid in 1980, (45  
14 cents per 32 lb bucket); and

15  
16 **WHEREAS**, most workers have to pick over twice the number of buckets per hour  
17 today as they did in 1980 in order to earn minimum wage; and

18  
19 **WHEREAS**, in 2005 after a four-year boycott, CIW reached a historic agreement with  
20 Taco Bell to pay farm workers more; and

21  
22 **WHEREAS**, in April, 2007, McDonald's also agreed to work with CIW to improve farm  
23 worker wages and working conditions; and

24  
25 **WHEREAS**, Burger King has refused to work with CIW. Instead, it's putting profits  
26 ahead of dignity and justice for workers; and

27  
28 **WHEREAS**, the one cent per pound increase would cost Burger King only \$250,000 per  
29 year; and

30  
31 **WHEREAS**, three private equity firms are major shareholders in Burger King -  
32 Goldman Sachs, Texas Pacific Group, and Bain Capital; and

33  
34 **WHEREAS**, 12 Goldman Sachs executives received bonuses exceeding \$200 million -  
35 more than twice as much money as all of the roughly 10,000 tomato pickers in southern  
36 Florida earned in 2006; and

37  
38 **WHEREAS**, Senator Bernie Sanders released two letters signed by four US Senators -  
39 Sen. Sanders, Sen. Richard Durbin, Sen. Edward Kennedy, and Sen. Sherrod Brown -  
40 sent to John Chidsey, CEO of Burger King Corporation, and Reggie Brown of the  
41 Florida Tomato Growers Exchange (FTGE), urging both Burger King and the FTGE to  
42 participate in the CIW-led initiative to improve farm worker wages and end the  
43 exploitation of Florida's tomato harvesters.

45 **THEREFORE BE IT RESOLVED THAT**, Senators Patty Murray and Maria Cantwell  
46 join U.S. Senators Sanders, Durbin, Kennedy and Brown in sending letters to John W.  
47 Chidsey and Reggie Brown.

49 **THEREFORE BE IT RESOLVED THAT**, we support a NATIONAL BOYCOTT of  
50 Burger King until such time as that company reaches an agreement with the Coalition  
51 of Immokalee Workers.

53 **BE IT FINALLY RESOLVED THAT**, notification of this action shall be mailed to: John
