

1                                   **A Resolution to Support the Federal**  
2                                   **Affordable Care Act and Stop the Lawsuit of the**  
3                                   **Attorney General**

4  
5 **WHEREAS**, in Washington State, close to 1 million residents do not have health  
6 insurance;

7  
8 **WHEREAS** the lack of health insurance is a major barrier for Washington State  
9 residents in obtaining needed and preventative health care;

10  
11 **WHEREAS** the inability to access affordable health care in a timely manner leads to  
12 uninsured individuals delaying and deferring care until an ailment becomes an  
13 emergency, which is more costly and leads to worse health outcomes; and

15 **WHEREAS** the federal Patient Protection and Affordable Care Act will benefit  
16 Washington State residents by

- 17                   • providing access to insurance for uninsured individuals with preexisting  
18                   conditions;
- 19                   • prohibiting health insurance companies from imposing preexisting  
20                   condition exclusions on children's coverage;
- 21                   • extending dependent coverage to young people up to age twenty-six;
- 22                   • strengthening community health centers; and
- 23                   • providing tax credits to small businesses that contribute to provide health  
24                   insurance to affordable, comprehensive health care services on an  
25                   equitable basis so that all individuals can access the right care in the right  
26                   place at the right time;

27  
28 **THEREFORE BE IT RESOLVED** that the Washington State Democrats recognize that  
29 the federal Patient Protection and Affordable Care Act will directly benefit Washington  
30 State residents that lack health care insurance or are underinsured;

31  
32 **THEREFORE BE IT FURTHER RESOLVED** that the Washington State  
33 Democrats support the federal Patient Protection and Affordable Care Act as advancing  
34 the goal of all people having access to affordable, comprehensive health care services on  
35 an equitable basis;

38 **THEREFORE BE IT FURTHER RESOLVED** that the Washington State  
39 Democrats support Washington State Governor Christine Gregoire's position that the  
40 federal Patient Protection and Affordable Care Act is in the interests of the state of  
41 Washington, and adamantly oppose Washington state Attorney General Rob  
42 McKenna's participation in a lawsuit challenging the constitutionality of the Patient  
43 Protection and Affordable Care Act;

45 **THEREFORE BE IT FURTHER RESOLVED** that the WA State Democrats call upon  
46 our state legislature to take immediate action to terminate state funding for this lawsuit  
47 and take other actions which they deem appropriate to require Attorney General  
48 McKenna to cancel participation by the people of the great state of Washington; and

50 **THEREFORE BE IT FINALLY RESOLVED** that a copy of this resolution be  
51 transmitted to relevant officials along with a request for response within thirty days,  
52 listing the actions they are willing to take to support this resolution or a list of the  
53 reasons explaining why it cannot be supported.
