

Resolution Supporting Two-State Solution to Israeli-Palestinian Conflict

4 **WHEREAS** ending the conflict between Israel and the Occupied Palestinian Territories
5 depends on the mutual recognition of Israel and Palestine as two viable independent
6 nations, with permanent rights to exist and to have their own governments;

8 **WHEREAS** the continued conflict between Israel and the Palestinian Liberation
9 Organization, Palestinian Authority and Hamas have brought death to both Israelis and
10 Palestinians and continued poverty and misery to millions in the area;

12 **WHEREAS** the Hamas Charter calls for the annihilation of Israel, the establishment of
13 the Islamic Caliphate that existed prior to World War I, and the unlimited conquest of
14 lands and people to spread Islamic law through violent Jihad;

16 **WHEREAS** the Israeli Likud political party fundamental documents assert that Israel
17 should include parts of the West Bank/Occupied Territories;

19 **WHEREAS** all peoples of the region need access to vital resources including clean
20 water, electricity, transportation, medical supplies, and infrastructure to support
21 commerce and healthy community; and

23 **WHEREAS** Article 3 of the 4th Geneva Convention forbids attacks on civilian
24 populations, and Article 49 of the 4th Geneva Convention specifies that an occupier
25 may not forcibly deport protected persons, or deport or transfer parts of its own civilian
26 population into occupied territory;

28 **THEREFORE BE IT RESOLVED** that the Washington State Democrats urge the United
29 States to call on the Palestinian Liberation Organization, Palestinian Authority and
30 Hamas to recognize the existence of Israel and to renounce any principles of their
31 charters and governments which call for the destruction of Israel, which demonize the
32 Israeli people, and which call for the spread of Islam by violent Jihad;

34 **THEREFORE BE IT FURTHER RESOLVED** that the Washington State Democrats urge
35 the United States to call on Israel to cease expanding settlements and building housing
36 inside the West Bank/Occupied Territories, and to make privately-funded settlements
37 and housing construction in those territories illegal;

39 **THEREFORE BE IT FURTHER RESOLVED** that the Washington State Democrats urge
40 the United States to reduce the amount of military and financial aid provided to Israel
41 commensurate with the amount of any new expenditure by the Israeli government to
42 expand settlements; and

44 **THEREFORE BE IT FINALLY RESOLVED** that this resolution be transmitted to the
45 United States Secretary of State, the National Security Adviser, and the Washington
46 State Congressional delegation along with a request for response within thirty days,
47 listing the actions they are willing to take to support this resolution or a list of the
48 reasons explaining why it cannot be supported.
